## **Stuffed Green Peppers (Microwave)**

1 lb. hamburger

2 (8 oz.) cans tomato sauce

3 T. grated Parmesan cheese

1/8 tsp. pepper

4 medium green peppers



Shirley Christopherson

1/3 c. chopped onion

1/4 c. water

tsp. salt

1/2 c. pkg. precooked rice

Crumble beef. Add onion. Heat to high for 3-1/2 to 4-1/2 minutes, until meat is brown. stirring once. Drain. Stir in 1 can tomato sauce, water, 1 tablespoon cheese, salt and pepper; heat, covered, 2-1/2 to 3-1/2 minutes. Stir in rice. Cover and let stand for 5 minutes. Cut peppers in half lengthwise. Remove seeds and rinse. Spoon beef-rice filling into each half; place in a glass baking dish. Top with other can of tomato sauce (I use a larger can tomato sauce for the top) and cheese. Heat, covered, 10 to 15 minutes at high, or until peppers are tender. Let stand, covered, for 5 minutes.

## Bishop Dan Schwerin Assigned to Northern Illinois-Wisconsin Episcopal Area as of Sept. 1

The North Central Jurisdictional Conference of The United Methodist Church, meeting July 10-13 in Sioux Falls, S.D., affirmed the assignment of Bishop Dan Schwerin to the Northern Illinois-Wisconsin Episcopal Area, effective Sept. 1,

The NCJ Committee on Episcopacy, which determines the bishops' assignments, announced them on July 13.

"We are excited to welcome Bishop Dan Schwerin back to Wisconsin, this time as our bishop!" said Jessica Gobel, chair of the Wisconsin Delegation. "The Wisconsin Conference is looking forward to experiencing all the blessings and gifts Dan has to offer and beginning our partnership with Northern Illinois as a shared episcopal area. Please join our delegation in welcoming Bishop Dan to Wisconsin.

"I am delighted that Bishop Dan Schwerin is returning to Northern Illinois," said Rev. Alka Lyall, chair of the Northern Illinois delegation for Ohio Episcopal Area: Bishop Hee-Soo Jung this year's United Methodist General Conference and the NCJ conference. "We have begun some good work in our conference, a spirit of trust is being felt, and we can now build onto momentum. I invite us to partner with him and grow the beloved communities in our conference."

"The Wisconsin Conference has enjoyed so many gifted and impactful episcopal leaders," said Bishop Schwerin. "And Julie and I have been blessed by the kindness we have received from the Northern Illinois Conference and the eighteen impactful months in ministry we have had there.

"We feel humbled and blessed to be assigned to serve among you. We now have the chance to experiment and innovate with two conferences' sharing one bishop in the new Northern Illinois-Wisconsin Episcopal Area. I can't wait to see what God will do through us." Bishop Schwerin was elected bishop in November 2022 and assigned to the Northern Illinois Conference starting January 1, 2023.

Bishop Hee-Soo Jung served the Wisconsin Conference from 2012 to 2024.

"My deep appreciation to Wisconsin. We will miss you. I welcome Bishop Dan Schwerin and give thanks for his visionary leadership. He knows us and he has been a vital part of our mission and ministry. Thank you to the NCJ Community for reaffirming us with new possibilities," shared Bishop Jung. Bishop Jung has been assigned to the Ohio Episcopal Area.

In January, NCJ established two new episcopal areas: one comprising the Wisconsin and Northern Illinois annual conferences and another comprising the Western Ohio and Eastern Ohio annual conferences. This reduced the number of bishops serving NCJ's ten conferences to seven, relieving pressure on the denomination's stressed Episcopal Fund.

In May, the UMC General Conference instructed the NCJ to reduce by an additional bishop. The jurisdiction is working on identifying a third episcopal area that will comprise two annual conferences.



#### REFLECTIONS ON ANNUAL CONFERENCE BY: ANN YELLE...LAY MEMBER TO ANNUAL CONFERENCE

The 2024 Wisconsin Annual Conference of the United Methodist Church was held in Green Bay, Wisconsin, from June 7-10. I have been a lay member to Annual Conference for about 15 years. As I have indicated in previous years. I have found this to be a most valuable experience for learning about the United Methodist Church. The theme for this year's conference was, "Abundant God; Beloved Community," which is based on John 10:10b: "I came that they may have life and have it abundantly."

The plenary sessions, or the business of the church, was quite ordinary this year. There were no controversial issues. We were updated, via reports and presentations from various committees, boards, ministries, etc., that operate within the Wisconsin Conference, or are in partnership or supported by the Conference. As a connectional church, the UMC is involved in many areas locally and throughout the world. One ministry. Global Ministries, serves as the missional arm of the United Methodist Church, dedicated to following the example of Christ, by aiding those in need. Thus, there are numerous committees involved in performing the work of Global Ministries. The priority areas of Global Ministries are Missionaries, Evangelism and Church Revitalization, Global Health, and Humanitarian Relief and Recovery, Mission work to Bolivia continues to be an area of help. An additional area of service to Bolivia, a goal for 2025, is the raising of funds for the Home for the Elderly in Bolivia. A mission of Global Missions, that Our Savior's and Gilmanton UM Churches participated in, was the making of Dignity Kits. This year, 35 kits were taken to the Midwest Missions' warehouse and subsequently distributed, as needed, locally and throughout the world in times of disaster. Midwest Mission has grown, enabling them to open a second warehouse.

Statistics were shared. Statistics come off of the EZRA report that churches need to submit, electronically, by February of each year. From Appointments of pastors to new churches were read and also the 2022 to 2023 there was a 12 percent change in the number of UM Churches in Wisconsin. The number dropped from 448 to 396. Membership decreased from 42,233 to 38,680 for this same period of time. Of the 52 churches that are no longer part of the annual conference, 43 of them were formal disaffiliations. Average weekly Sunday School attendance was down by 5 percent. The average church size in Wisconsin is about 100. Fifty percent of the churches have less than 58 members. Regarding apportionment payments, 215 churches paid their apportionment in full. Wisconsin Conference paid their global apportionment payment at 100 percent. In 2023, the conference expenses were under budget. For 2025, the minimum compensation for Elders. Provisional Members, and Associate members serving full time, will be \$50,236. Two churches were discontinued, Granton UMC and Cristo La Roca UMC, and one was abandoned. Chili Immanuel UMC.

It was approved that the Wisconsin Conference be organized into 4 districts, down from the 5 districts and 5 district superintendents since 2015. We continue in the North West District. Wisconsin will now share a Bishop with Northern IL, with the Episcopal area office being in

Glenview, IL. Since Annual Conference, Dan Schwerin was assigned as Bishop of the Northern Illinois-Wisconsin Episcopal Area, effective September 1st. Bishop Jung, our Bishop for 12 years, the maximum number of years allowed, will be moving to the Ohio Episcopal Area.

It was reported that the conference received concerns regarding Church Mutual, the insurance carrier for the churches in the conference. Because Church Mutual will not serve all of the churches, a new carrier is being sought. Four carriers are being explored and hopefully will present bids soon.

In his state-of-the-church address, Bishop Jung recounted highlights from his time with our conference. A few of the highlights were that he visited every church in the conference, experienced 31 new church starts, continued the relationship with the Dongbu Conference of the Korean Methodist Church, worked with the Evangelical Methodist Church in Bolivia, and experienced the exceeding of our apportionment to global giving.

An update on General Conference was shared: The concept of Regionalism is being voted upon across the world and it will come before the 2025 Wisconsin Annual Conference; Harmful language against LGBTQIA+ was removed; Social Principles are being revised for the first time in 50 years: a full communion relationship with the Episcopal Church is pending approval by the Episcopal Church; sacramental authority by Deacons was expanded.

Activities that we shared in included an excellent Bible Study, worship. communion, singing, praying, meeting new people, reconnecting with people met over the years, etc. In addition, we shared in a Service of Remembrance, where persons connected to the Wisconsin Conference, who had died since the previous conference, were honored. We also honored pastors for their length of service, beginning at 25 years. 417 combined years of service were honored. names of clergy retiring were read.

As at other Annual Conferences, the Recognition, Commissioning, and Ordination Service continues to be a very special service. Four were licensed as local pastors, four were commissioned as elders, six were ordained as elders, and two were ordained as deacons. Adding to my love of this service, was the ordination of our former pastors. Joeng and Clare. It was so fun to meet both pastors' families, including Evalena Margaret, Pastor Clare and husband Cory's young daughter, who they call Lena.

The last activity was a farewell celebration for Bishop Jung. This was an opportunity to thank him for all that he has done for the churches of the Wisconsin Conference these last 12 years.

I again thank you for the opportunity to represent Our Savior's and Gilmanton UMCs at Annual Conference. I continue to pray for our local churches, and also the United Methodist Church throughout the world. Let us make disciples of Jesus Christ for the transformation of the world.
